#### **GENERAL SERVICE HIGHLIGHTS**

Routine park maintenance has been slowing down in regard to public use and general upkeep.

We have been preparing our equipment for winter operations. A few vehicles will be getting tires replaced, including our primary salt truck. Replacement of cutting blades for the underbody scraper will be needed also.

Vactor had an oil pump that had to be replaced a couple of weeks ago. We were able to tow it back with the loader to the shop for in-house repairs.

Potholes have been filled along all village roadways.

Storm water collection basins are being cleaned out that were impacted from the various washouts from the 7 inches of rain recently.

Alley grading behind Cozy Cottage up towards Concord was completed along with re pitching the slope to improve adverse effects from runoff.

#### **UTILITY HIGHLIGHTS**

Distribution System of Materials Inventory (DSMI) which corelates with the Water Reliability Study as mentioned in prior reports, is ready to start after village water supply chlorination next week. Other tasks include coinciding with the DSMI is a GIS integrated Cross Connection Program. Both programs will be part of the Village GIS system. Our department will be out "daylighting" randomized residential water leads within our distribution system.

Cross-connection inspection site visits for local businesses are anticipated to start in October.

The water valve exercising program is completed.

Harbor Heights Update: awaiting bacteriological test results from developer. Storm water infrastructure and water services to be installed in the next phase.

SCADA has been installed at Port Sutton and Bayview station along with a new integrated station controller at Bayview which was malfunctioning due to age.

The sewer lining project experienced main line structural failure in a section of existing pipe that will have to be replaced.

### **REGULATORY HIGHLIGHTS**

Village water supply monthly sample results were all clear. Chlorination begins 10/2 thru 10/6/2023 along with hydrant flushing and winterization.

#### **PURPOSE**

To discuss the purchase of two replacement sewage pumps.

#### **OVERVIEW**

The proposal before you has been forthcoming since we canceled the \$450,000 lift station project in 2019.

We found that the catalyst of this new lift station was the *discussion* of a 32-unit proposed residential project, which is now referred to as Harbor Heights. Rather than get into all the details, we eventually had the current lift station evaluated by another engineering firm. The results were not surprising in that we did not need a new \$450,000 lift station, rather, upgrades to the current lift station would suffice.

Fast forward to 2022. There was an element of uncertainty associated with the construction of the project, so we did not budget in those fees or the pump upgrades. I have attached Report VSB-2023-35, which was presented to the council in June and requested two budget amendments to reflect the payment of those fees. We are now looking to purchase two sewage pumps with those funds. Being that the pumps were not budgeted, we will need VC permission to move this forward.

#### **OVERVIEW**

Although we typically wait and lump budget amendments into an end of the year request, we are recommending that the 2023 sewer and water budgets be amended to reflect the fees that were paid by the Harbor Heights development.

## REQUEST #1 -To amend the 2023 Sewer Fund budget as follows:

### Revenues

Increase 590-000-476 Permits and Fees by \$176,000 from \$5,500 to \$181,500

# **Expenditures**

Increase 590-537-756 Collection Supplies by \$4000 from \$6500 to \$10,500 and

Increase 590-537-974 Collection Cap Improv by \$172,000 from \$80,000 to \$252,000.

**MOTION THAT:** the 2023 Sewer Fund budget be amended, as stated in Report VSB-2023-35 and being made a part of this motion.

### REQUEST #2 -To amend the 2023 Water Fund budget as follows:

#### Revenues

Increase 591-000-476 Permits and Fees by \$112,000 from \$500 to \$112,500

### **Expenditures**

Increase 591-000-756 Supplies by \$4000 from \$13,000 to \$17,000 and

Increase 591-000-974 by \$108,000 from \$20,000 to \$128,000.

#### **PURPOSE**

To discuss the purchase of a bypass pump.

#### **OVERVIEW**

Sewage bypass pumps are rarely used outside of emergencies, however, not having this piece of equipment when an emergency does occur adds an unnecessary risk to an already difficult situation. As you are aware, a bypass pump is needed when one our sewage lift station pumps breaks down and can no longer pump sewage through the system and to the wastewater treatment plant.

These emergencies often occur at inopportune times, which limits our ability to address the sewage concern in an efficient manner. Rather, when an emergency occurs, we sometimes find ourselves having to wait several hours before being able to rent a bypass pump. The bypass pump is then rented until the lift station pump can be removed, sent out to be repaired, and reinstalled. This is a very costly process.

In 2022, we budgeted an amount of \$50,000 for the purchase of a bypass pump this year. As with everything, the cost has risen and has now exceeded our estimated budgeted amount by approximately \$20,000. We have reached out to other professionals familiar with these pumps to gather their opinion on the pump and its cost. It appears that everyone is in agreement that the cost is fair and the purchase was recommended.

Prior to moving forward with this purchase, we would need support from the committee to elevate this purchase to the Village Council. We will then prepare the request for village council consideration, which due to the additional cost, would likely include an amendment to the budget.

#### RECOMMENDATION

Our community is well overdue on this purchase and following an evaluation of our budget and the additional \$20,000 needed for the purchase we are comfortable recommending this purchase.

# Recommendations; Marina Fee Schedule 2024:

To keep up with operational costs and increased utilities I am suggesting an increase in Seasonal Slip Fees. Rates would increase from \$83 per ft. in the main marina to \$88 per ft. The Coal Dock rates would increase from \$73 per ft. to \$79 per ft. There is a flat rate for boats 25' and under. Main Marina \$2,200, Coal Dock \$1,950. These rate increases are still below other municipal marinas in the Bay. Northport and Elk Rapids is \$94 per ft. with expected increases for 2024. Elmwood and Clinch are at \$110 per ft.

Transient rates were not increased last year in 2023. In 2024 I suggest that we increase from the Waterways Rate Schedule of E to F. We are currently \$34 for vessels 25' and under with a \$1 per additional ft. The F schedule would take us to \$37 for vessels 25' and under with a \$1 per additional ft. Currently Northport is on the F Rate schedule with no plan for increase in 2024. Elmwood, Elk Rapids and Clinch are on the G Rate Schedule with \$40 vessels 25' and under an additional \$1 per ft.

Day Use/Shopper Docks are constantly busy and take up a lot of staff's time. We currently change \$3 an hour for these slips. This rate has not been increased in over 10 years. I am suggesting that we increase this fee to \$5 an hour to help offset the costs involved with these slips.
